## **BBSC Minutes of Meeting**

*April 2, 2024*

The meeting was attended by 14 members.

Location of the meeting was the Masonic Lodge in Alpine. The meeting was called to order at 6:00pm by president Jim Westermann. John O Hollis gave the invocation.

### *Reports*

The March 5th minutes were read by Scott McClanahan. Kyp Angel motioned to accept and Mike Boren seconded, and the minutes were accepted.

No treasurer's report this month.

### *Old Business*

Phil O'Shaughnessy reported on shotgun activities with the HSCTL league starting Friday.

Luke Hendryx, the County Extension Agent, spoke about the 4H Clubs and adult certification. May 22nd and 23rd will have adult certification. There are three certifications - muzzleloader, shotgun, and rifle. "Texas requires that hunters who were born on or after September 2, 1971, must first complete a course approved by the Texas Parks and Wildlife Department and IHEA-USA." This is called Hunter Education. Adults born after the mentioned date need this TPWD Hunter Education Certificate before taking the 4H adult certification courses. It is also a good idea for adults to get certified to teach Hunter Education. In the fall is a Post Park competition with many Boy Scout-like activities for youth.

Caroline Luna spoke about the HSCTL. There are 11 students signed up. Some have no experience and others much. A college league with the same organization may start in the fall at Sul Ross. Caroline expects her high school league to be larger in the fall. The students are in the tri-county Homeschool Coop.

The 2A Swap Meet is scheduled for May 18th 10am to noon at the Mason's Building. Firearms, NO AMMO again. The swap meet is for BBSC Members Only.

Jim Westermann talked about the Big Bend Shooting Foundation Banquet. Dawson Young is the president, and Jim is head of the banquet committee. There will be 20 to 25 8-person tables and the Table of Guns raffle will happen! That's where a winning table wins the same gun for each person at the table.

Range closures reported by Robert Johnson are May 9th & 10th 8am to 3pm Pistol #1 (big range) for LEOs. Also May 13th 6 pm to 10pm Pistol #1 for LEOs.

The rifle range has another set of swinging targets. There are still problems with the welded nuts breaking on the pistol steel targets. Shot up frames are filling up the frame houses.

# **Armed Attorneys**

## **React to ATF Ruling**

### **A Report by Scott McClanahan**

The Armed Attorneys are Richard D. Hayes II and Emily Taylor based in Houston Texas. The Gun Owners of America recommends watching their series on You Tube.

There are three episodes concerning the new ATF ruling. Links to the three episodes are included at the end. The last episode is more specific with answering questions and is a good place to start.

## **Questions and Answers Episode 3 (4-20-2024)**

### Summary

The new ATF ruling is about engaging in the business of dealing firearms. The proposed rule has been finalized and now transmitted to the code of federal regulations. This is an attempt by Biden to close the gun show loophole. The new ruling is a rule heavily restricting the sale of firearms. If you intend to make a profit, then you are engaged in the sale of firearms. You need a license. If not, then you can be prosecuted as an unlawful dealer of firearms. The purpose of the new ruling is to scare every firearm owner by the Biden Administration.

### Questions from Viewers

1. What if selling a firearm at a loss?  
Even if you lose money, you intended to make a profit.
2. What if selling several firearms?  
Even if at a loss, intent to sell for a profit is still there.
3. What if you gift to a family member?  
That would likely be okay under the new rule.
4. What if selling a firearm and use an FFL (Federal Firearms License) for the transfer?  
Only if happened occasionally. If done repeatedly, then you could be construed to be a dealer.
5. How would this ruling affect bartering and trading? What is the motivation behind the disposition the firearm?  
There is a problem with self defense firearms. Enhancing your private collection is probably okay. You have to consider the IRS view of making a profit. The ATF says bartering and trading does not exempt you from this rule. All of the same considerations apply.
6. Is it illegal to buy a gun from an unlicensed seller?  
No, the buyer is entirely unaffected.

7. How are the feds going to enforce this?  
If the transaction is talked about (such as online) or documented, ATF may find out. Gifting many guns can lead to prosecution.
8. Would government gun buybacks be considered selling under the new rules?  
Yes.
9. Is pawning a gun considered selling under the new rules?  
Can't prove a profit motive with pawn shops. Attorneys recommend not pawning your guns.
10. What about estate sales?  
Inheriting and then selling an estate is okay.
11. What about selling to an FFL?  
The occasional rule applies here also.
12. Is the rule change retroactive?  
Thirty days after transmitted to the federal register and published, the rule would normally go into affect. However, the law went into affect June 25, 2022, so this ruling is different. Transactions after June 25, 2022 could be implicated. Do not try to sell guns before the rule goes into affect. The law and ATF ruling do not mirror each other.

Sales to an FFL do not exempt you from this new rule.

There is no definition of the word occasional.

Many of these answers are opinions on issues that need to be litigated.

## **Episode 1 (4-16-24)**

### Summary

Livelihood was removed from the definition of an FFL. One no longer has to be in the business, just motivated by profit. One has to have an FFL for repetitive sales. The new ruling may not require repetitive sales for operating as an unlicensed gun dealer. The point of this law is that if you make a private sale, you do so unlawfully and need an FFL. The attorneys have to recommend to clients to not do any private sales at this time.

### Scenarios as an Unlicensed Dealer

The attorneys offer several scenarios for being prosecuted as an unlicensed dealer.

1. You sold a firearm (private purchase) that comes back to haunt you. The firearm gets used in a crime, recovered, and traced back to you. Or, the firearm is lost or stolen and recovered, and it is automatically traced. Basically, any encounter by a firearm you once owned with law enforcement is a legal liability! The trace starts at the manufacturer, goes to the distributor, then to an FFL, and finally to you. This is a different crime than the case



doing the trace, and the trace is automatically sent to the federal prosecutor. An innocent sale, say to a relative, could have them sell it, lose it, or stolen.

2. A firearm you sold in private transaction is used in a self defense event, that firearm will be traced as mentioned above. Emily said a full trace is run in half of her cases.
3. The person buying the gun is a criminal, and the firearm is used in a the commission of a crime. There are separate laws about selling a firearm to a known criminal.
4. A federal sting operation at a gun show hits the private sellers. Even happenstance, such an ATF agent happens to be at the gun show and sees a cash, private transaction.
5. Federal agents watching online market places catch private transactions, such as social media or bulletin boards. Gunbroker and other auction houses require transferring to an FFL.

Traditionally, suspicion of selling firearms generated a letter from the ATF with a notice that has to be signed and returned, with the stipulation to cease and desist. Prosecutors may use a gun sale as a point of prosecution.

## Episode 2 (4-20-2024)

### Summary

1. What the law change is.
2. Who the ATF is targeting.
3. The bait and switch of the proposed rule and what we got on the books.

Bipartisan Safer Communities Act is the law enacted June 25, 2022. The wording was changed, as shown below. We moved from livelihood to simply earn a profit. That's going from many transactions to one. Here is the previous law.

(21) The term "engaged in the business" means (C) as applied to a dealer in firearms as defined in section 921(a)(11)(A), a person who devotes time, attention, and labor to dealing in firearms as a regular course of trade or business **with the principal objective of livelihood and profit** through the repetitive purchase and resale of firearms, but such term shall not include a person who makes occasional sales, exchanges, or purchases of firearms for the enhancement of a personal collection or a for a hobby, or who sells all or part of his collection of firearms.

We changed the definition of what it means to be engaged in the business of dealing firearms by changing the above bold phrase to "**to predominantly earn a profit.**" "To predominantly earn a profit" is a new term. The definition is shown below.

(d) Predominantly earn a profit

(1) Definition. The intent underlying the sale or disposition of firearms is predominately one of obtaining pecuniary gain, as opposed to other intents, such as improving or liquidating a personal firearms collection. Provided: that proof of profit, including the intent to profit, shall not be required as to a person who engages in the regular and repetitive purchase and disposition of firearms for criminal purposes or terrorism. For purposes of this section, a person may have the intent to profit even if the person does not actually obtain the intended pecuniary gain from the sale or disposition of firearms.

Why do we have this difference between code and regulations? When Congress passes a law it has a purpose. However, the extent of the law (for example, how much poison is allowed in our food supply) will split hairs and get an expert opinion, the regulatory people. They determine how much poison is allowed in order to execute the will of Congress. The regulatory bodies have gotten out of hand to the point of changing the definition. The Biden administration directed the ATF to make these changes in the code. This is taking the laws of Congress and abusing the citizens. The law passed by Congress does not mirror the rules and regulations.

Next we look at the mechanics of this ruling and who the ATF is targeting. This is a fundamental change of the definition of who is a firearms dealer. The law and the regulations were a bait and switch scheme by the Biden administration on all citizens by making everyone a firearms dealer.

There are three definitions to know. The first is the definition of the term dealer.

#### **478.11 Meaning of terms. Dealer**

Dealer. Any person engaged in the business of selling firearms at wholesale or retail, any person engaged in the business of repairing firearms or of making or fitting special barrels, stocks, or trigger mechanisms to firearms, or any person who is a pawnbroker. The term shall include any person who engages in such business or occupation on a part-time basis. The term shall include such activities wherever, or through whatever medium, they are conducted, such as at a gun show or event, flea market, auction house, or gun range, or club, at one's home, by mail order, over the internet (e.g. online broker or auction) through the use of other electronic means (e.g. text messaging service, social media raffle, or web site), or at any other domestic or international public or private marketplace or premises.

There were not substantial changes to the term dealer. Everyone's a dealer!

Next is engaged in the business of selling firearms.

#### **478.11 Meaning of terms. Dealer**

(a) Definition. A person who devotes time, attention, and labor to dealing in firearms as a regular course of trade or business to predominately earn a profit through the repetitive purchase and resale of firearms. The term shall not include a person who makes occasional sales, exchanges, or purchases of firearms for the enhancement of a personal collection or for a hobby, or who sells all or part of the person's personal collection of firearms. In addition, the term shall not include an auctioneer who provides only auction services on commission to assist in liquidating firearms at an estate-type auction, provided that the auctioneer does not purchase the firearms or take possession of the firearms for sale on consignment.

So, if part of your personal collection, all's good? We're not done yet. What is a personal collection? Let's define that.

**478.11 Meaning of terms. Personal collection (or personal collection of firearms, or personal firearms collection).**

(1) General definition. Personal firearms that a person accumulates for study, comparison, exhibition (e.g. collecting curios or relics, or collecting unique firearms to exhibit at gun club events), or for a hobby (e.g. noncommercial, recreational activities for personal enjoyment, such as hunting, skeet, target, or competition shooting, historical re-enactment, or noncommercial firearms safety instruction). The term shall not include any firearm purchased for the purpose of resale with the predominant intent to earn a profit (e.g. primarily for a commercial purpose or financial gain, as distinguished from personal firearms a person accumulates for study, comparisons, exhibition, or for a hobby, but which the person may also intend to increase in value). In addition, **the term shall not include firearms accumulated primarily for personal protection.** Provided: that nothing in this section shall be construed as precluding a person from lawfully acquiring firearms for self-protection or other lawful personal use.

**Your personal collection does not include firearms "primarily for personal protection."** This is the kicker. Buy all the Glocks you want, but none are part of your personal collection. The Second Amendment is about personal protection, so this bold move by the Biden administration may be its undoing as unconstitutional.

There are lots of presumptions in the new rules, and everything makes you a firearms dealer. The law talks about presumptions near the end.

(h) Criminal proceedings. The rebuttable presumptions in paragraphs (c) and (d)(2) of this section shall not apply to any criminal case, although they may be useful to courts in criminal cases, for example, when instructing juries regarding permissible inferences.

There are also some presumptions that you are not a firearms dealer.

1. a bonafide gift.
2. occasionally selling one firearm to acquire a more valuable firearm for your personal collection, possibly in trade with additional money.
3. occasional lawful transfers to family members.
4. to liquidate without restocking all firearms in your collection, such as an estate sale, **without restocking. An estate sale means you can never buy a firearm again!** This is really the entire point of the new laws - to get you in this situation.
5. liquidating a gun collection under court order.
6. the role of auctioneer - running auctions - even online auctions, like gunbroker. Auctioneers are not considered firearms dealers.

What will the legal challenge to the new rules look like? The best challenge may be an individual, a good person, that gets wrapped up in buying and selling a few guns. There may be an administrative procedures challenge or a Second Amendment challenge - both proactive. There could be a situation of standing (having asked the ATF for permission to sell, then prosecuted later).

The new rules affect way more people than other ATF rulings. They affect everyone that owns a gun and considering selling it.

# **Texas State Rifle Assc Scholarships**

It's time to RELOAD a new Scholarship Award Year! 2024-2025 scholarship applications are now available online at [www.tsra.com](http://www.tsra.com).

There are 4 scholarship programs available for graduating TSRA Junior Members or those currently attending college.

1. The George E. Tubb Memorial Scholarship is available specifically for applicants attending or enrolled at Texas A&M-College Station.
2. The William T. Clarke Jr. Memorial Scholarship require applicants to be applying to or attending a Texas-accredited college or university full-time.
3. The Paul Bartlett and Mrs. Kitty Benson Memorial Scholarships require applicants to be applying to or attending a Texas-accredited college or university full-time.
4. The Sportsman's Scholarship requires applicants to be enrolled to attend, or attending, as a full-time student, at a Texas institution of higher learning, which is a junior college, 4-year College/University, Trade or Vocational institution, and pursuing a major that enhances hunting, wildlife management, and conservation. A few examples include but are not limited to, wildlife management and conservation, natural resources/range/forestry management, wildlife biology, or zoology.

Please review the application for each scholarship for further criteria, as each scholarship may vary based on shooting sports, marksmanship, Second Amendment, or conservation/hunting activities required for eligibility. If eligible, applicants may apply for more than one TSRA/TSRAF scholarship; however, they may only receive one if selected.

Completed scholarship applications are due by 5:00 pm, Friday, June 14, 2024. Incomplete or late applications will not be considered.

## **William T. Clarke Jr. Memorial Scholarship**

The William T. Clarke Jr. Memorial Scholarship is available to Texas residents (graduating high school seniors or current university students), who must be a TSRA member, have a shooting background, be a full-time student, and maintain a grade point average of 2.75 or greater at their selected Texas college or university. Clarke Scholarships are for students with a shooting background.



Clarke Scholarships will be for \$2,000, with \$1,000 awarded for the fall semester, and if scholarship criteria are maintained, another \$1,000 awarded for the spring semester.

## **Paul Bartlett & Kitty Benson Memorial Scholarships**

These scholarships are available to Texas residents (graduating high school seniors or current university students), who must be a TSRA member, have a shooting background, be a full-time student, and maintain a grade point average of 2.75 or greater at their selected Texas college or university. Bartlett & Benson Scholarships are for students with a shooting background. The Scholarships will be for \$1,000, with \$500 awarded for the fall semester, and if scholarship criteria are maintained, another \$500 awarded for the spring semester.

## **Sportsman's Scholarship**

The TSRA Foundation Sportsman's has been established thru the generosity of an anonymous donor for use at their selected Texas college or university. The Sportsman's scholarships is dedicated to recognize, encourage and promote the education of our future leaders in wildlife management, hunting heritage and activities, firearm safety, and conservation of Texas wildlife. Students majoring in programs that enhance hunting and firearm safety, wildlife management, and wildlife conservation can apply. TSRAF Sportsman's scholarships awarded will be for \$2,000, with \$1,000 awarded for the fall semester, and if scholarship criteria are maintained, another \$1,000 awarded for the spring semester.

## **Standard Application Guidelines**

Standard applications notes for all available scholarships. Some scholarships may have additional criteria, please review each application carefully.

Applicants may be active in any firearm related discipline.

Applicants must be a Texas/U.S. resident and a current TSRA member.

Applicants must be enrolled as a full-time student at a Texas institution of higher learning. This includes but is not limited to: Junior college, 4-year College/University, Trade or Vocational institutions.

High School Seniors may apply but must show proof of acceptance to their selected Texas institution of higher learning.

Current college students must have an overall GPA as outlined on each scholarship application.

Applicants must be enrolled/accepted as a full-time College/University student in Texas. Applicant must remain a full-time student throughout the entirety of the academic semester. A full-time student is defined as a minimum of 12 hours per semester. (Graduate students are not eligible.)

Applicants may apply for any and all TSRA/TSRAF related scholarships; however recipient may only be granted one annually.

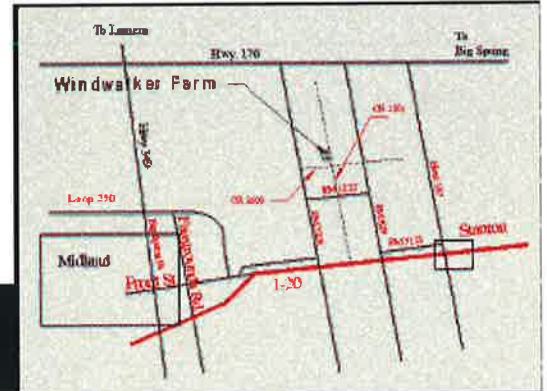
